

Anti-Slavery and Human Trafficking Statement

Modern slavery is a crime resulting in an abhorrent abuse of the human rights of vulnerable workers. It can take various forms, such as slavery, servitude, forced and compulsory labour and human trafficking. The Company has a zero tolerance approach to modern slavery and is committed to acting ethically and with integrity and transparency in all of our business dealings and relationships and to implementing and enforcing effective systems and controls to ensure that modern slavery and human trafficking are not taking place anywhere within either our own business or in any of our supply chains, consistent with our obligations under the Modern Slavery Act 2015. We also expect the same high standards form all of our suppliers, contractors and other business partners and as part of our contracting processes, it includes specific prohibitions against the use of modern slavery and expects that all our suppliers will in turn hold their own suppliers to the same standards.

Identifying potential victims of modern slavery can be a challenge because the crime can manifest itself in many different ways. There is a spectrum of abuse and it is not always clear at what point, for example, poor working practices and lack of health and safety awareness have become instances of human trafficking, slavery or forced labour in a work environment. In addition, some suppliers may go to great lengths to hide the fact that they are using slave labour. The Company accepts that we have a responsibility through due diligence processes to ensure that workers are not being exploited, that they are safe and that relevant employment, Health and Safety and human rights laws and standards are being met, including freedom of movement and communications.

This policy applies to all individuals working for the Company or on the Company's behalf in any capacity, including employees, directors, officers, agency workers, contractors, consultants and business partners.

Our Business

ASI Group Limited operates a variety of heavy goods vehicles and trailers covering the UK. The family run business specializes in access and plant equipment movements, heavy haulage, bulk waste haulage machinery installations and equipment refurbishment. ASI Group Limited also has its own workshop for maintaining and repairing company and customer vehicles.

High Risk Areas

Our highest risk is from Human Trafficking, people trying to stow people in our vehicles at European Borders.

Policies and Controls

We have internal policies to ensure that we are conducting business in an ethical and transparent manner. These include our Whistleblowing Policy, aimed principally at our employees but also available to others working in our supply chains which encourages staff to report any wrongdoing which extends to human rights violations like Modern Slavery. We also have a Modern Slavery Policy that is supplied to employees, contractors, suppliers and customers. All reports are fully investigated and appropriate remedial actions taken.



Due Diligence and Audit of Suppliers and Supply Chain

We undertake due diligence when taking on new suppliers and annually audit current suppliers by selfassessment documentation as well as visits to site by our H&S Team. We ensure all of our employees are eligible to work in the UK and check licenses, certification etc. We encourage all of our staff but particularly our drivers to report any concerns they may have when delivering/collecting loads from our customers.

Responsibility for this Policy

The Board of Directors has overall responsibility for ensuring that this policy complies with the Company's legal and ethical obligations.

Samantha Croxton, H&S and Transport Manager, has day to day responsibility for implementing this policy, monitoring its use and effectiveness and auditing internal control systems and policies and procedures to ensure they are effective in preventing or remediating the risk of modern slavery. She is also responsible for investigating allegations of modern slavery in the Company's business or supply chains.

Managers and Transport Planners are responsible for ensuring that those reporting to them understand and comply with this policy.

Training and Communication

Training is provided on this policy and on the risk to the business from modern slavery at induction and refreshed annually as part of the internal compliance audit. H&S representatives will raise the topic of modern slavery with their drivers on a regular basis and bring any concerns to the formal meetings. All staff will be given training on how to identify exploitation and modern slavery and how to report suspected cases. Our zero-tolerance approach to modern slavery must be communicated to all suppliers, contractors and other business partners when entering into new or renewed contracts with them.

Breach of Policy

Any employee who breaches this policy will face disciplinary action, up to and including summary dismissal for gross misconduct. The Company may terminate its commercial relationship with suppliers, contractors and other business partners if they breach this policy and/or are found to have been involved in modern slavery.
